Suggested Baseline Documentation Format

Acknowledgements and Signatures (this should be first/last – acknowledging and accepting the document in its entirety)

- 1. Land Info:
- Owner information
- Parcel Data (plat, lot, acreage, street address)
- Land—general description, current land use
- Conservation Easement Name
- Conservation Easement Information (brief description, reference to book/page where recorded)
- Conservation Values, Uses, and Restrictions (summary as recognized in CE or deed)
- Landuse History (from historic aerial photos or other if known; previous land uses)
- 2. Purpose of Protection or Use statement of purpose from land conservation organization (often found in CE or deed)
- 3. Property Description
- Boundaries landscape position/surrounding land use
- Topography
- Soils
- Agricultural Values (if appropriate)
- Wetlands/Rivers/Streams
- Water Resources—ground water, watershed
- Flora & Fauna list wildlife values, natural communities, invasive species, species of conservation concern
- Historic, Educational, Recreational, & Scenic Values (as appropriate)
- Roads & Trails
- Structures/Human disturbance/Alterations
- 4. Photo Documentation of Parcel
- Listing of Photos-date, photographer (with signature), locations, views
- Photo location map
- Photos—perimeter boundary photos, others
- 5. Maps for clear depiction of the following:
- Copy of Plat Map
- Copy of Survey Plan (if available)
- Aerial Photograph showing property boundaries, location, etc.

- Topography
- Soils
- Wetlands—with disclaimer "not for regulatory use"
- Watersheds
- Other plan maps (context for protection, existing trail sustem, etc.)
- Nearby protected lands and open space/trails/connectivity

Appendices:

- Preparer's Qualifications
- Recorded Deeds—CE or fee simple
- Recorded survey page
- Exhibits—Metes & Bounds description, Restrictions
