Narragansett Bay and Watershed Restoration Fund *	Who can apply?	When will funds be available?
NEW Flood Prevention Grants: \$3 million in state bond funds available statewide for projects that mitigate flooding through ecological restoration. Requires 25-50% match. Projects must reduce flooding problems while also providing ecological co-benefits. Examples:	State and local governmental entities; watershed organizations, other NGOs.*	Statewide RFP to be issued Spring 2017
Stormwater Management Grants : \$ 3 million in state bond funds available for projects that reduce stormwater pollution by <i>construction</i> of green infrastructure and other stormwater BMP, elimination of illicit discharges, capital expenses for equipment (govt only) and sustainable financing projects (govt only). Requires 25-50% match.	State and local governmental entities; watershed organizations, other NGOs, businesses.*	Statewide RFP to be issued Spring 2017
Nonpoint Source Pollution Abatement Grants: Up to \$500,000 in federal EPA funds administered by RIDEM may be available for projects that <i>implement</i> actions to abate nonpoint sources of water quality degradation. Projects must align with watershed -based management plans. Focus for 2017 is on restoration of riparian buffers. Other eligible projects may include agricultural BMPs, certain on-site wastewater projects. Stormwater projects only in non-MS4 designated areas. Requires 40% match. <i>Picture courtesy of WRWC.</i>	Local governments, watershed organizations, conservation NGOs. 2017 Eligible watersheds: Barrington-Palmer-Warren Rivers, Bristol-Kickemuit, Nonquit Pond, Aquidneck Island, Wood-Pawcatuck	Targeted RFP to be issued in Spring 2017 jointly with BWRF funds
Aquatic Invasive Species Management Grants: BWRF state grants to assist implementation of actions to control the growth of aquatic invasive species in freshwater lakes. 50% match required. Projects need to be consistent with lake management plan or AIS management plan/documented strategy.	Lake associations, local governments, watershed organizations, NGOs, businesses.*	Subject to the availability of funding. No RFP is scheduled at this time.
Marine Pump-Out Facilities & Pump-Out Boats: DEM distributes USFW Service funding in accordance with Clean Vessel Act to establish, maintain and repair marine pump-out facilities and boats. Requires 25% match.	Municipalities, qualified public and private marinas, yacht clubs	RFP planned for May 2017

All RIDEM grants are governed by written agreements and provide for reimbursement of properly documented expenses.

Matching expenses can include in-kind contributions of labor, materials and other services. Project periods are typically 1-3 years depending on the complexity of the project. Projects involving solely the planning and design of a project are generally ineligible. Grants are generally not awarded to individuals.
